

The Abstract should be structured into the following sections: Title, Authors (List of authors, presenting author listed first), Affiliation (Institutional Affiliation), E-mail and phone number of submitting author, Type of Study: (Clinical/Basic/Experimental), Objectives, Methods, Results, and Conclusions.

Guidelines on Submission of Abstracts:

- Registration for the conference is mandatory for presentation of the abstract.
- The abstract (about 300 words) must be submitted online only in MS-word file (Font: Times New Roman, 12 size, and 1.5 line spacing).
- Abstracts will be judged according to the scientific merit and relevance by the scientific committee.
- The presenting author should be willing to present the work during the conference as a poster presentation as assigned by the scientific committee.
- If an abstract is accepted as a poster presentation, the presenting author will be requested to be available for discussion during the corresponding poster viewing session.
- 5. At the time of abstract submission, the submitter must identify who will be the presenting author. To be eligible to present, authors will be required to confirm they had full access to all of the data in the study and take responsibility for the integrity of the data, accuracy of the data analysis, and approving the data for presentation. The presenting author need not be the first author, but must be a listed author on the abstract. Only one presenter is permitted per abstract.

Notification of the accepted abstract will be mailed to the authors by 02th March, 2019.
